Sails Up 4 Cancer has been able to assist many local cancer care centers such as Hospice organizations, our local Cancer care hospital, children afflicted with cancer, and both individuals and families struggling financially while battling cancer.

If you wish, Sails Up would like to encourage your organization to apply for one of our grants. Institutions may apply for grants with the emphasis on needs and earmark exactly what the funds will be used for. Evidence of the use of funds will be required within a specified time frame. Cancer patients and families may apply for grants through our Spinnaker Fund.

Policies and Guidelines

1. Grants are made on an annual basis.
2. Grants shall be limited to 501(c) 3 or (c) 6 non-profit, equal opportunity organizations as identified by the Internal Revenue Service.
3. Grants for individuals may also be awarded through the Spinnaker fund. Please request alternate form.
4. Grantees must demonstrate financial responsibility
5. No single grantee shall receive all of the available funding in any one calendar year.
6. No grants will be made for endowments, deficit financing, or for reimbursements for purchases prior to grant request.
7. Grant limit is set at \$5000
8. Spinnaker fund applicants need only complete the Grant Cover form.
9. We want to know how you are doing; a subsequent report is required one year from application process if funds are granted to your organization.
10. Media events and press release permission is required and by applying for this Grant you agree to this term.

Please see the subsequent pages for the application. Applications are accepted throughout the year but no later than November 15 of the calendar year. Applications must include all required supporting data. Announcement of grant recipient will be made no later than 60 days post application date. A letter will be sent to all applicants regarding acceptance or denial.
